

BATS BZX Exchange Pricing Effective October 1, 2013

Please be advised that effective October 1, 2013, pricing will be updated on the BZX Exchange (*subject to filing with the SEC*) as follows.

NBBO Joiner Program¹

Through the NBBO Joiner Program, the BZX Exchange allows Members to earn an additional \$0.0001/share rebate on executed orders that improved the BZX Best Bid or Offer (BBO) and resulted in the BZX Exchange BBO joining an existing National Best Bid and Offer (NBBO). To qualify for the NBBO Joiner Program, Members must achieve at least Tier 2 shown above. Only the first order received that results in the BZX Exchange BBO joining the NBBO at a new price level will qualify for the incremental rebate.

NBBO Joiner fills will carry a 'J' identifier in the *SubLiquidityIndicator* field of Execution Reports in BOE or 9730 (*TradeLiquidityIndicator*) = 'AJ' in FIX. This new field value is available immediately in the BZX Certification environment.

NBBO Setter Program²

Through the existing NBBO Setter Program, Members will continue to earn an additional \$0.0002/share rebate on executed orders that resulted in the BZX Exchange setting the NBBO. To qualify for the NBBO Setter Program, Members have been required to achieve an ADV of at least 0.5% (added + removed volume) of TCV on BZX Exchange. On the effective date, Members will also be able to qualify for an improved NBBO Setter rebate by achieving an ADV of at least 0.2% (added volume) of TCV on BZX Exchange.

Thus, any Member achieving at least Tier 2 shown above will qualify for both the NBBO Joiner and Setter Programs.
