

EDGX Options Exchange Fee Schedule Update Effective May 2, 2016

Overview

Effective **Monday**, **May 2**, **2016**, Bats Global Markets will introduce the following pricing changes on EDGX Options Exchange, pending filing with the SEC.

Customer Volume Tiers (Fee Codes PC, NC)

Customer Volume Tier 6 will be updated for Customer orders in either Penny or Non-Penny Pilot securities (fee codes PC, NC).

Tier	Rebate per contract for a Customer order	Required Criteria	
Tier 6	(\$0.21)	 Member has an ADV in Customer Orders equal to or greater than 0.25% 0.20% of average TCV Member has an ADV in Market Maker Orders equal to or greater than 0.25% 0.15% of average TCV 	

Market Maker Volume Tiers (Fee Codes PM, NM)

A new Market Maker Volume Tier 7 will be introduced for Market Maker orders in either Penny or Non-Penny Pilot securities (fee codes PM, NM).

Tier	Transaction Fee/Rebate per contract for a Market Maker order	Required Criteria
Tier 7	\$0.10	 Member has an ADV in Customer Orders equal to or greater than 0.20% of average TCV Member has an ADV in Market Maker Orders equal to or greater than 0.15% of average TCV

RQ	\$0.70	Routed to ARCA, BZX Options, C2, ISE, ISE Gemini, NOM (Customer), Penny Pilot
RR	\$0.90	Routed to ARCA, BZX Options, C2, ISE, ISE Gemini, NOM (Customer), Non-Penny
