

Bats Access Services Fee Schedule Changes Effective January 3, 2017

Overview

Effective **Tuesday**, **January 3**, **2017**, Bats Global Markets will introduce the following updated Access Services fees for all U.S. Exchanges including the Bats BZX Exchange (BZX), BYX Exchange (BYX), EDGX Exchange (EDGX), EDGA Exchange (EDGA), BZX Options Exchange, and EDGX Options Exchange, pending filing with the SEC.

Logical Port Fees

The fees for logical ports to the Bats equity exchanges will be \$550 per month for all ports. Logical port fees for the Bats options exchanges will not change.

Physical Port Fees

The fees for 10 Gb physical connections used to access the Bats equity and/or options exchanges will be \$6,000 per month. The fees for 10 Gb physical connections used solely for access to non-Bats markets and/or data through the Bats Connect service will remain at \$4,000 per month. The fees for 1 Gb physical connections will not change.

Bats Connect Fees

The fees for access to non-Bats markets and/or data through the Bats Connect service will be the following:

The Unicast Access fees will not be charged for bandwidth required to access BZX, BYX, EDGA, EDGX, BZX Options, and EDGX Options. Firms are required to pay any exchange related data fees directly to that exchange.
