RE: Product Delisting

Regulatory Circular #04-26

Following the recommendations of the Allocation Committee, CBOE has determined to delist the thirty-four (34) option classes listed below in accordance with Exchange Rules and the Exchange's delisting policy. These options classes either no longer meet the Exchange's listing standards, or trade a low number of contracts per day and/or have low open interest. As a result, these option classes no longer warrant the expenditure of CBOE's resources which otherwise would be necessary to maintain the listing.

The process of delisting the option classes listed below, with the exception of multiply traded classes which may be immediately delisted by CBOE, will involve the prompt delisting of series in which there is currently no open interest and no additional series will be added in the future. The Committees will continue to review all CBOE option classes on a periodic basis for additional delisting candidates, and will make recommendations to the Office of the Chairman consistent with CBOE's Rules and its delisting policy.

The delisting process for the following options classes will commence as of the close of business on Friday, February 20, 2004.
