RE: Restrictions on Transactions in Adjusted Gold Fields Limited (GFI1)

Updates Regulatory Circular RG13-028

Effective February 21, Gold Fields Limited ("GFI") had a distribution of shares in which resulted in Gold Field Limited adjusted symbol (GFI1). Part of the deliverable for the Gold Field Limited adjusted symbol ("GFI1") is Sibanye Gold Limited ("SBGL"). Sibanye Gold Limited ("SBGL") is listed on the NYSE MKT. Therefore, Gold Field Limited adjusted symbol ("GFI1") is not subject to restrictions. Restrictions in Gold Field Limited adjusted symbol ("GFI1") are lifted effective immediately.
