RE: Relocation of Option Classes

The Chicago Board Options Exchange, Incorporated ("CBOE" or "Exchange") has determined to relocate all classes currently traded at Post 6, Station 6 to Post 4, Station 5, pursuant to CBOE Rule 8.95 and Regulatory Circular RG15-156.¹ The Designated Primary Market Maker ("DPM") appointments in the affected options classes will remain unchanged.²

Additionally, pursuant to CBOE Rule 8.95 and Regulatory Circular RG15-156, the Exchange has determined to relocate the following classes from Post 6, Station 9 to Post 4, Station 5:
