

Cboe Options Regulatory Circular RG17-181

To: Cboe Options Trading Permit Holders

RE: Restrictions on Transactions in Dextera Surgical, Inc. (DXTR)

Effective December 13, 2017, Dextere Surgical (DXTR) was delisted from the NASDAQ and moved its listing to the Other-OTC Market under the symbol DXTR. Therefore, trading in DXTR options will be subject to restrictions.

Trading on Cboe Options in existing series of DXTR options will be subject to the following restrictions. Only closing transactions may be affected in any series DXTR options except for (i) opening transactions by Market-Makers executed to accommodate closing transactions of other market participants and (ii) opening transactions by Cboe Options TPH organizations to facilitate the closing transactions of public customers executed as crosses pursuant to and in accordance with Cboe Options Rule 6.74(b) or (d).

The execution of opening transactions in DXTR options, except as permitted above, and/or the misrepresentation as to whether an order is opening or closing, will constitute a violation of Cboe Options rules, and may result in disciplinary action. TPH organizations should ensure that they have appropriate procedures in place to prevent their customers from entering opening orders in this restricted option class. In addition, transactions in contravention of this restriction may be subject to nullification pursuant to Cboe Options Rule 6.25.

There are no restrictions in place with respect to the exercise of DXTR options.
