RE: Order Routing of Broker-Dealer and Firm Orders

As of December 29, 1998, the Exchange will allow for the routing of all broker-dealer and firm orders to PAR and Mobile PAR in all trading crowds. **The Equity Floor Procedure Committee** has decided that market-maker orders, if sent by a member firm as origin type "Broker-Dealer" or "Firm," will be directly routed to crowd printers at each trading station, not to PAR.
