Partial Amendment

BATS Exchange, Inc. (the “Exchange” or “BATS”) is filing this partial amendment to SR-BATS-2010-002, which was originally filed on February 2, 2010, and which was amended on February 22, 2010, to add additional text to the purpose section of the filing. Specifically, at the bottom of page 4 of 33, at the end of footnote 4, the Exchange proposes to insert the following text:

The Exchange is in the process of drafting, and represents that it will file with the Commission pursuant to Section 19(b)(1) of the Act and Rule 19b-4 thereunder, a proposed rule filing detailing each of the data feeds that it provides free of charge.

The Exchange proposes inserting the same language on page 18 of 33, at the end of the footnote 4.

No other changes are proposed through this partial amendment.
