Partial Amendment No. 1 to SR-CboeBZX-2018-079

Cboe BZX Exchange, Inc. (the “Exchange” or “BZX”) is filing this Partial Amendment No. 1 to SR-CboeBZX-2018-079, which was originally submitted on October 18, 2018 (the “Proposal”). Pursuant to the Proposal, the Exchange proposed a rule change to amend how the BZX Official Closing Price would be determined for BZX-listed securities. This Partial Amendment No. 1 proposes to make a clarifying change to the Proposal. The Exchange believes that this proposed change clarifies and adds additional detail to the Proposal, as further described below, and is consistent with the Securities Exchange Act of 1934 in that it adds additional detail to the Proposal and eliminates potential confusion.

The Exchange is proposing to delete and replace paragraph (a) under Item 2 in the Form 19b-4 Information, which currently states:

The Exchange’s President (or designee) pursuant to delegated authority approved the proposed rule change on [DATE], 2018.

The Exchange is proposing to replace that paragraph with the following language:

The Exchange’s President (or designee) pursuant to delegated authority approved the proposed rule change on October 18, 2018.

As noted above, the Exchange believes that this proposed change adds clarifying information related to details about the Proposal and is consistent with the Securities Exchange Act of 1934 in that it adds additional detail to the Proposal and eliminates potential confusion.
