

FINAL REMINDER - BATS Announces Support for Attributed Quotes Effective May 7, 2012

Overview

BATS is pleased to announce support for attributed quotes will be made available to Members of BATS BYX Exchange, BZX Exchange and BATS Options effective Monday, May 7, 2012. On the effective date, Members will be allowed to opt-in to having their TCP and Multicast PITCH quotes attributed to their MPID on an order by order basis. Additionally, summarized quote and/or trade activity related to attributed quotes will be made available on the BATS public web site.

Members will have to execute an attribution addendum to their User Agreement in order to opt-in to attribution functionality. Executed addendums can be submitted to <u>BATS Membership Services</u>.

BYX Exchange, BZX Exchange and BATS Options Members using TCP and/or Multicast PITCH must be prepared to support changes to both protocols on Monday, May 7, 2012. In preparation for the hard cut to the updated protocols, BATS has defined a testing schedule that is outlined below.

Order Attribution

On the effective date, Members that have executed an attribution addendum **and** requested that the <u>BATS Trade Desk</u> enable attribution on a firm or port level may have their PITCH quotes attributed on an order by order basis by setting BOE field *AttributedQuote (FIX Tag 9732)* = 'Y'. This field may be set to default to 'N' or 'Y' at the firm or port level.

TCP PITCH Specification Update

On the effective date, BYX Exchange and BZX Exchange Members using TCP PITCH must be prepared to support an additional 4 byte MPID on the Add Order (long) message as highlighted below.

On the effective date, BYX Exchange, BZX Exchange and BATS Options Members using Multicast PITCH must be prepared to support an additional 4 byte MPID on the Add Order (expanded) message as highlighted below.
