#### C1 Integration Schedule (COMPLETE)

04/30/18	SPX A.M. settled options converted to the standard Hybrid trading platform.
10/15/18	Rollout of PAR 2.0 (new floor terminals) begins.
11/16/18	Technical Specifications for C1 on Bats technology will be made available on the <a href="#">technical specifications website</a> .
02/01/19	Physical connections to the new C1 platform accepted.

	<i>C1 will have dedicated network infrastructure and customer connections, separate from our other U.S. equity and options exchanges.</i>
03/04/19	Certification period for customer testing begins.
04/02/19	Logical order entry ports will be created on the new production trading platform for every login that exists on the current production trading platform for C1 effective this date. A single FIX Drop port will be created for every firm as well. C1 TPHs may begin ordering additional logical ports or requesting unnecessary ports be deleted within the new production environment. TPHs will be required to audit their production sessions to ensure they have a desirable number prior to the migration to the new production platform.
05/06/19	Daily (Monday – Friday) trading of TEST SYMBOLS ONLY in new C1 NY5 production environment.
06/15/19	Weekend test opportunity in new C1 production environment.
07/27/19	Weekend test opportunity in new C1 production environment.
08/24/19	Weekend test opportunity in new C1 production environment.
09/14/19	Weekend test opportunity in new C1 production environment.
09/28/19	Weekend test opportunity in new C1 DR environment.
