Beginning **Monday, October 8**, Cboe plans to offer trading in Cboe<sup>\*</sup> iBoxx<sup>\*</sup> iShares<sup>\*</sup> \$ Investment Grade Corporate Bond Index (IBIG) futures. ### **Expanded Pre-Open Hours for CFE Products**

On **Monday, October 8**, Cboe Futures Exchange (CFE) will adjust the start of the Pre-Open (queuing) period for all futures contracts, with the exception of Cboe Volatility Index (VIX) futures and Cboe Bitcoin (USD) (XBT) futures. The start time of the pre-open period for all non-VIX and XBT products will be updated from 6:00 a.m. CT on that business day to 5:00 p.m. CT on the previous calendar day to align with VIX and XBT futures.
