Cboe to Launch Fixed Income Futures on iBoxx iShares Indexes

Last week, Cboe announced a collaboration with IHS Markit BlackRock for Cboe to develop the first-ever broad-based U.S. corporate bond index futures.

Cboe plans to offer cash-settled futures on the iBoxx iShares USD High Yield Corporate Bond Index (ticker: IBHY) this summer, pending regulatory review. Designed to leverage the deep and liquid iShares ETF ecosystem, IBHY measures the performance of U.S. dollar-denominated high-yield corporate debt, and offers broad coverage of the liquid U.S. high-yield corporate bond universe.

The iBoxx iShares USD High Yield Corporate Bond Index is a market-cap weighted index of U.S. dollar-denominated, sub-investment grade corporate debt with at least one year to maturity. The index is rebalanced monthly.

IBHY futures will be cash-settled and traded electronically on CFE. The contracts will be cleared through OCC.
