#### Cboe Options Exchange Technology Conference Call on March 19

Cboe Global Markets will conduct its next technology migration customer conference call at 11:30 a.m. CT on **Tuesday, March 19**. Cboe will update customers on the planned migration of Cboe Options Exchange (C1) to Bats technology on **October 7, 2019**, subject to regulatory review.

## **Cboe Announces Complex Reserve Orders on C2 Options Exchange**

Effective **Friday, March 15**, Cboe will introduce Complex Reserve orders on the C2 Options Exchange (C2). This new feature is being released in preparation for migration of C1.

On the effective date, C2 will support complex reserve orders, the reserve portion of which will only be executed after all displayed quantity at that price level has been executed. See the **Tradedesk Update**.
