

The **Cboe UK Alternative 100** index aims to be comprised of the 100 largest assigned AIM market issuers that are quoted in Sterling on NEX, measured by their full market capitalisation. The index base level is 10,000 as of June 21st, 2013. This is a price return index.

Objective

The index is designed for use in the creation of index tracking funds, derivatives and as a performance benchmark.

Investability

Stocks are selected and weighted to ensure that the index is investable.

Liquidity

Stocks are screened to ensure that the index is tradable.

Transparency

Uses a transparent, rules-based construction process. Index Rules are freely available on the cboe.com/indexeurope website.

Availability

Calculation is based on price and total return methodologies, both real-time, intra-second and end of day.

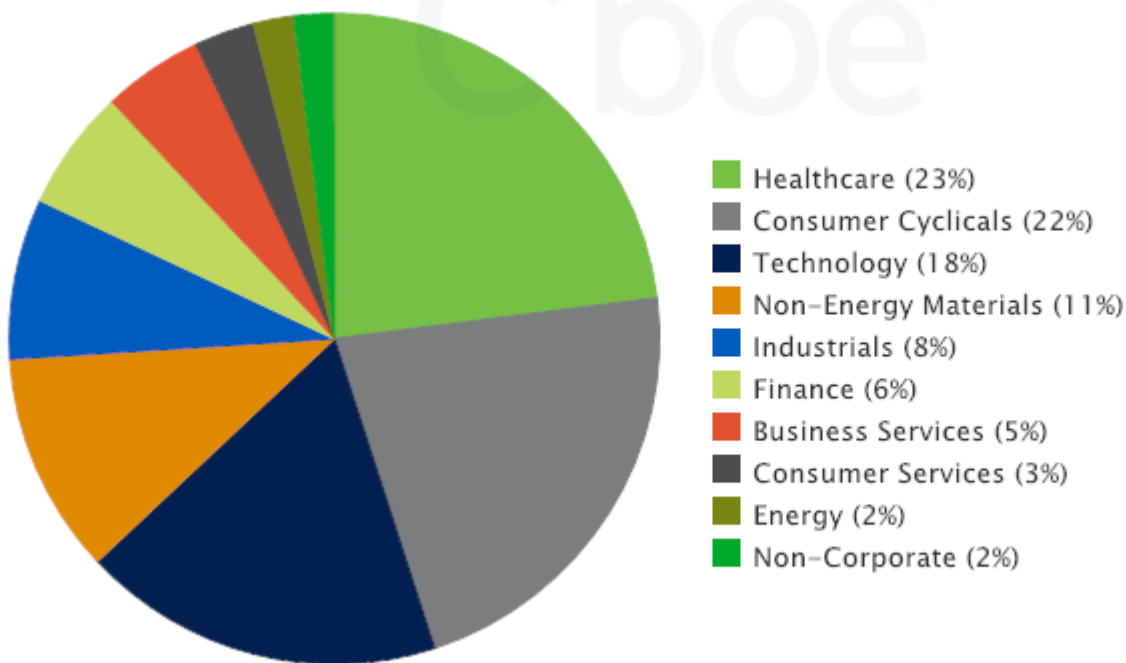
