

The **Cboe UK Small Cap** index will be comprised of the UK issuers included in the Cboe UK All Companies index but which are not constituents of the Cboe UK 350. The index base level is 10,000 as of December 31st, 2010. This is a price return index.

### Objective

The index is designed for use in the creation of index tracking funds, derivatives and as a performance benchmark.

### Investability

Stocks are selected and weighted to ensure that the index is investable.

### Liquidity

Stocks are screened to ensure that the index is tradable.

### Transparency

Uses a transparent, rules-based construction process. Index Rules are freely available on the [cboe.com/indexeurope](http://cboe.com/indexeurope) website.

### Availability

Calculation is based on price and total return methodologies, both real-time, intra-second and end of day.

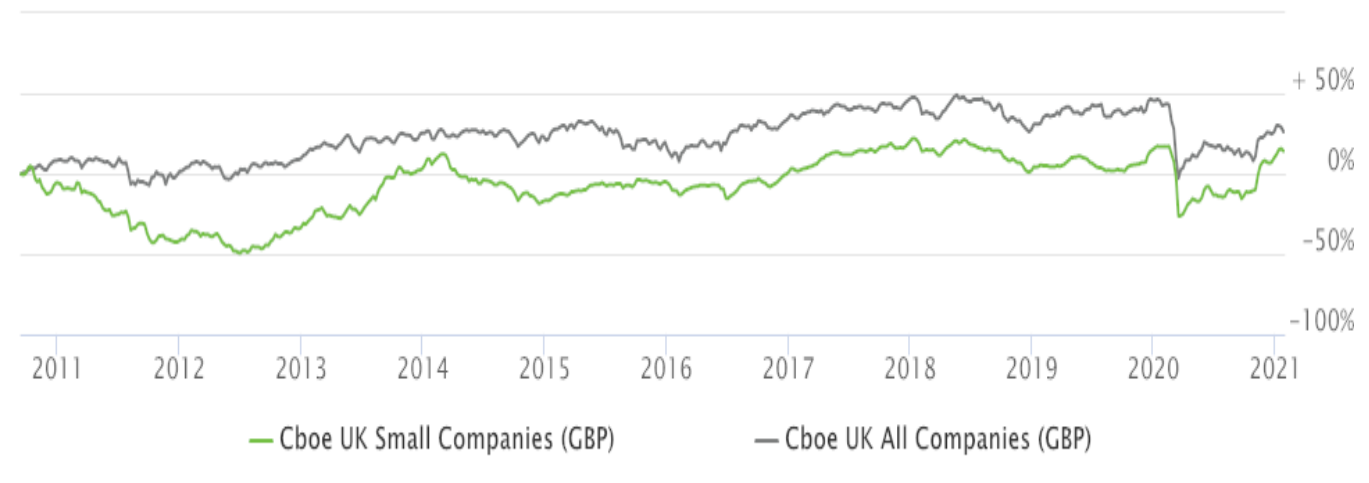

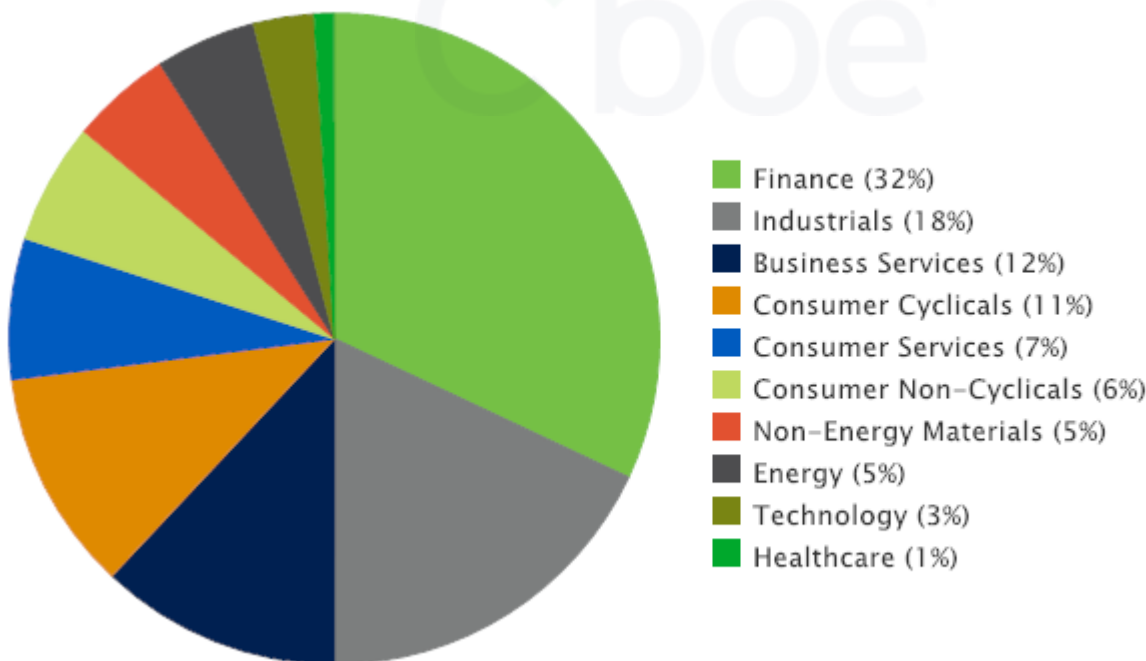
