

## 2nd Reminder - Notice of Fee Changes for Cboe Streaming Market Indices (CSMI) Effective August 1, 2021

## **Overview**

**Effective August 1, 2021**, CSMI channel fees will be adjusted to account for changes to licensed use of historical data, channel content, and channel availability. In particular, the new fee structure reflects:

- 1. Cboe will include a license for the display, internal use, and/or controlled external use of historical fees (according to the CSMI subscription type) in the price of CSMI subscriptions.
- 2. The CCCY channel now includes exclusive CoinRoutes RealPrice data, which is a real-time price for cryptocurrencies, based on the fee-sensitive, consolidated order books from all accessible exchanges.
- 3. The MSCI channel, which is currently available only to retail enterprise level subscribers of the CSMI Main Channel, will be available for subscription by any CSMI customer.

The amended fee schedule is as follows. All other fees not mentioned will remain the same. A revised version of the CSMI Fee Schedule that reflects these changes will be provided on the CSMI <u>website</u> soon.
