

Operational Changes for Cboe Streaming Markets Indexes (CSMI) to Accommodate Dissemination of Real-Time Indexes from Global Markets

Overview

Cboe Global Markets is preparing to distribute real-time indexes over CSMI feed channels from global markets that operate outside of US trading hours. The Japanese Government Bond Volatility index value (JGB VIX) will be the first index disseminated outside of US trading hours. JGB VIX will be disseminated over the CSMI channel. The changes listed below will apply to all data channels: CSMI, FTSE, MSCI, INAV, and CCCY.

Operational Hours

- Effective June 17, 2019, Global Index support operational hours will run from 14:30 CST Sunday through 19:00 CST on Friday.
- The operational hours of all CSMI feed channels will be changed: CSMI, FTSE, MSCI, INAV, and CCCY.
- The times at which US index values are disseminated will not change.
- Due to this change, heartbeats may be transmitted outside of market hours without the presence of index values.

Sequence Numbers

- The current daily sequence number reset will be discontinued.
- Sequence numbers for each channel will reset once starting on Sunday and increase throughout the week without interruption until the following Friday.

JGB VIX Dissemination Times

- The JGB VIX real-time calculation will be disseminated during Osaka Exchange trading hours, excluding Osaka Exchange holidays. A complete Osaka Exchange Holidays schedule is available at <https://www.jpx.co.jp/english/corporate/calendar/>.
- JGB VIX will be disseminated from 08:45 – 11:02 JST (Morning session) and 12:30 – 15:02 JST (Afternoon session).
 - JST is 15 hours ahead of CDT and 14 hours ahead of CST.
- Currently, the official close for JGB VIX is disseminated during US trading hours at 08:32 Central time. Once the real time dissemination of JGB VIX begins, the official close will be transmitted at approximately 15:30 JST.
