QUARTERLY MARKET IMPACT / TRADING PATTERN REPORT – Q3 2018 PM-SETTLED S&P 500 INDEX OPTIONS

On September 2, 2011, the C2 Options Exchange, Incorporated ("C2") received approval of a proposed rule change to list and trade PM-Settled S&P 500 Index Options that expire on the third Friday of the month on a 14-month pilot basis. The Chicago Board Options Exchange ("CBOE") became the sole market for PM-Settled S&P 500 Index Options on February 19, 2013. The pilot program expires on November 5, 2018, unless otherwise extended.

As part of this pilot program, on a periodic basis CBOE will submit reports analyzing volume and open interest for Expiration Friday, PM-Settled S&P 500 Index Option Series ("SPXpm"). Pursuant to the terms of the pilot program, CBOE is submitting this interim report to the SEC.

Monthly Analysis of Volume & Open Interest:

This interim pilot report data reflects trading activity in SPXpm options during Q3 2018 (July 1, 2018 through September 30, 2018).
