RE: Modified Trading Hours for Martin Luther King, Jr. Holiday

This circular sets forth the modified trading hours for CBOE Volatility Index (VX) futures and all other CFE products for the Martin Luther King, Jr. holiday. All times referenced in this circular are Chicago time.

Holiday Trading Schedule for Monday, January 16, 2017:**VX Futures**

The schedule below will apply for the Monday, January 16, 2017 holiday trading session¹ in VX futures, including Trade at Settlement (TAS) transactions in VX futures (Ticker: VXT):

Regular	None	8:30 a.m. to 3:15 p.m.

Trades in VX futures (including TAS transactions in VX futures) during the January 16, 2017 holiday trading session will be submitted for clearing on the Business Day of Tuesday, January 17, 2017.

ECRP Transactions and Block Trades in VX Futures

Exchange of Contract for Related Position (ECRP) transactions and Block Trades in VX futures may occur during the extended trading hours for VX futures on Monday, January 16, 2017, but may not occur outside of those trading hours. ECRP transactions must be reported by no later than 30 minutes after the transaction is agreed upon and Block Trades must be reported by no later than 10 minutes after the transaction is agreed upon. Notification to CFE by the Authorized Reporter for each party to any ECRP transaction or Block Trade that occurs during extended trading hours on Monday, January 16, 2017 may be made by e-mail to the CFE Help Desk or through the CFE Trade Reporting Tool in accordance with the regularly applicable procedures for those notification methods.

All Other Products

¹ A holiday trading session includes extended trading hours on the calendar day of the holiday and any extended trading hours for the holiday on the previous calendar day. Holiday trading sessions are not separate Business Days and are part of the next Business Day. Trading in VX futures is halted between sessions of extended trading hours on the calendar day of a holiday. The CBOE System will complete the processing of trades that are in the course of being processed by the CBOE System prior to the start of such a halt period. Trades in VX futures (including TAS transactions in VX futures) during the Martin Luther King, Jr. holiday trading session will be submitted for clearing on the Business Day of Tuesday, January 17, 2017.

Trading will be closed for all CFE products other than VX futures on Monday, January 16, 2017. Additionally, no ECRP transactions or Block Trades may occur in these products on Monday, January 16, 2017.

Time Frames for Submission of Quotes, Orders, Cancels and Modifications in VX Futures During Holiday Trading Session for Monday, January 16, 2017:

The chart below sets forth the applicable time frames for the submission of quotes, orders, cancels and order modifications in VX futures, including TAS transactions in VX futures, for the January 16, 2017 holiday trading session.

Sunday January 15, 2017	4:15 p.m. to 5:00 p.m.*	Pre-Open	Quotes, orders, cancels and modifications.
Monday January 16, 2017	5:00 p.m. (Sunday, January 15, 2017) to 10:30 a.m.	Extended Trading Hours	Quotes, orders, cancels and modifications.
Monday January 16, 2017	10:30 a.m. to 4:15 p.m.*	Halted	Orders, cancels and modifications. No quotes.
Monday January 16, 2017	4:15 p.m. to 5:00 p.m.*	Pre-Open	Quotes, orders, cancels and modifications.
Monday January 16, 2017	5:00 p.m. to 8:30 a.m. (Tuesday, January 17, 2017)	Extended Trading Hours	Quotes, orders, cancels and modifications.

*Quotes and orders permitted to be submitted to CFE's trading system during these times are not executable until extended trading hours next commence.
