Chicago Board Options Exchange, Incorporated ("CBOE" or "Exchange") hereby submits this Partial Amendment, constituting Amendment No. 1, to its rule filing SR-CBOE-2007-150 filed on December 20, 2007, in which the Exchange proposes to amend its Fees Schedule to make various changes for Fiscal Year 2008. The Exchange proposes to add language to Section 11 of the Fees Schedule relating to a cap on the proposed new Seat Transfer Fee.
