# 3. <u>Self-Regulatory Organization's Statement of the Purpose of, and the Statutory Basis</u> for, the Proposed Rule Change

The Exchange currently offers seven tiers under footnote 1 that offer reduced fees for displayed orders that yield fee codes B, V and Y, and an enhanced rebate for orders that remove liquidity yielding fee codes BB, N and W.
