(“BYX” or the “Exchange”) proposes to amend its fees and rebates applicable to Members<sup>3</sup> and non-Members of the Exchange pursuant to BYX Rules 15.1(a) and (c). Changes to the fee Schedule pursuant to this proposal are effective upon filing.

3. Self-Regulatory Organization's Statement of the Purpose of, and the Statutory Basis for, the Proposed Rule Change

(a) Purpose

The Exchange proposes to amend its fee schedule to add a new tier under footnote 1, Add/Remove Volume Tiers. The Exchange currently offers seven tiers under footnote 1 that offer reduced fees for displayed orders that yield fee codes B,<sup>4</sup> V<sup>5</sup> and Y,<sup>6</sup> and an enhanced rebate for orders that remove liquidity yielding fee codes BB,<sup>7</sup> N<sup>8</sup> and W.<sup>9</sup> The Exchange proposes to add a new tier under footnote 1, to be known as Tier 6,<sup>10</sup> under which a Member would be charged a reduced fee of \$0.0017 per share on orders that yield fee codes B, V and Y, where that Member's Market Participant Identifier ("MPID") has an ADAV<sup>11</sup> equal to or greater than 0.10% of the TCV<sup>12</sup> and a Step-Up ADAV equal

to or greater than 0.05% of the TCV from a September 2017 baseline.<sup>13</sup> The Exchange proposes to implement the above changes to its fee schedule on October 2, 2017.

(b) Statutory Basis

The Exchange believes that the proposed rule change is consistent with the objectives of Section 6 of the Act,<sup>14</sup> in general, and furthers the objectives of Section 6(b)(4),<sup>15</sup> in particular, as it is designed to provide for the equitable allocation of reasonable dues, fees and other charges among its Members and other persons using its facilities. The Exchange believes that the proposed tier under footnote 1 is equitable and reasonable because such pricing programs reward a Member's growth pattern on the Exchange and such increased volume will allow the Exchange to continue to provide and potentially expand the its incentive programs. The Exchange believes that providing the reduced rate to Members under proposed Tiers 6 is reasonable compared to the more stringent requirements under other tiers in footnote 1 that provide a further reduced rate. The Exchange further believes that the proposed tier is reasonable, fair and equitable because the liquidity from the proposed changes would benefit all investors by deepening the Exchange's liquidity pool, offering additional flexibility for all investors to enjoy cost savings, supporting the quality of price discovery, promoting market transparency and improving investor protection. These pricing programs are also not unfairly

discriminatory in that it is available to all Members.

In addition, volume-based fees such as that proposed herein have been widely adopted by exchanges and are equitable because they are open to all Members on an equal basis and provide additional benefits or discounts that are reasonably related to: (i) the value to an exchange's market quality; (ii) associated higher levels of market activity, such as higher levels of liquidity provision and/or growth patterns; and (iii) the introduction of higher volumes of orders into the price and volume discovery processes. The Exchange believes that the proposed tier is a reasonable, fair and equitable, and not an unfairly discriminatory allocation of fees and rebates, because it will provide Members with an additional incentive to reach certain thresholds on the Exchange.

#### 4. Self-Regulatory Organization's Statement on Burden on Competition

The Exchange does not believe that the proposed rule change will impose any burden on competition not necessary or appropriate in furtherance of the purposes of the Act. The Exchange does not believe that this change represents a significant departure from previous pricing offered by the Exchange or from pricing offered by the Exchange's competitors. The proposed rates would apply uniformly to all Members, and Members may opt to disfavor the Exchange's pricing if they believe that alternatives offer them better value. Accordingly, the Exchange does not believe that the proposed changes will impair the ability of Members or competing venues to maintain their competitive standing in the financial markets. Further, excessive fees would serve to impair an exchange's ability to compete for order flow and members rather than burdening competition. The Exchange believes that its proposal would not burden intramarket competition because the proposed rate would apply uniformly to all Members.
