

CFE to Commence Trading in Cboe Bitcoin (USD) Futures Soon

Overview

Cboe Futures Exchange, LLC ("CFE") plans to commence trading in Cboe Bitcoin (USD) Futures (futures symbol "XBT") on a date to be announced by CFE through the issuance of a circular¹. Cboe Bitcoin (USD) futures are cash-settled futures contracts that are based on the Gemini auction price for bitcoin in U.S. dollars.

Product Testing

As previously announced in CFE Information Circular <u>IC17-049</u>, XBT futures are currently available for testing in the API CFE test environment. CFE Trading Privilege Holders ("TPHs") that wish to test with XBT futures can contact the API Department at api@cboe.com or 312-786-7300 for additional details.

Initial Expirations

Below is a list of the XBT futures expirations that CFE plans to list for the XBT futures product launch and the last trading day² and final settlement dates³ for those contracts.

² The trading hours for expiring XBT futures contracts terminate at 2:45 p.m. CT on the Final Settlement Date.

³ The Final Settlement Date for serial XBT futures is two business days prior to the third Friday of the month denoted by the ticker symbol.
