

Choe Trade Floor Power Modifications

Overview

The Cboe Facilities and Technology departments have jointly been working to modify and enhance the electrical utility sourced power to the Trading Floor. Our goal is to convert the Trading Floor power source for typical utility to the building UPS and Generator systems. Our efforts have reached the final process and we will transition the floor in a phased approach, as follows.

Schedule

On Friday, April 20, 2018, the Facilities Department will facilitate the second phase of the Trading Floor power transition. In order to complete this work, we will need to shut down the power on the Trading Floor only for the (SPX pit), (Post 10), (Post 9) and all the Booth Rows and firm platforms on the East side of the Trading Floor.

The power-down will be between the hours of 5:00p.m. (Chicago time) Friday, April 20, 2018 and 6:00a.m. Saturday, April 21 2018. At 8:00a.m., Saturday, April 21, 2018 the Trade floor and its operation should be fully restored.

Impacts and Action Items

Please note this power-down and conversion event will **not** affect the Data Center or any Firm equipment in the Cboe Data Center or in the **East** Interstitial areas at 400 S LaSalle. However, all PC's, Servers, etc. located on the Trading Floor in the noted areas of power conversion will be affected.

As a result:

- > Trading Permit Holder (TPH) representatives should turn off their respective equipment housed on the Trading Floor on Friday, April 20, 2018, before leaving for the weekend.
- > During the power-down no one will be allowed access into the building.

TPHs and their representatives should arrange to come in and power up their respective systems on either Saturday April 21, 2018 between the hours of 8:00 a.m. and 12:00 noon (Chicago Time) or Sunday April 22, 2018 between the hours of 8:00 a.m. and 11:00 a.m. (Chicago Time). Access to the building will be permitted through the main entry (North Side). Those looking to gain entry will be required to have

a building ID. Cboe access badges will work on the Saturday or Sunday after the power shutdown even if the badge normally has only Monday through Friday access.
