

Choe Options Exchange Introduces Cash-Settled FLEX ETF Options

OVERVIEW

Applicable Cboe Exchange: Cboe Options

Effective August 1, 2023, Cboe Options Exchange ("C1") will introduce cash-settled FLEX Exchange-Traded Fund ("ETF") options, *pending regulatory review*.

TECHNICAL DETAILS

On the effective date, exercises and assignments for the new cash-settled FLEX ETF options will settle in cash (as opposed to physical underlying shares), with the settlement amount based on the difference between the closing price of the underlying security on the date of exercise and the strike price of the option. These cash-settled FLEX ETF options will have the same system functionality as regular FLEX options, including support for fixed or percent strike and premium, and execution via open outcry or electronic FLEX AIM, SAM and single-sided auction processes. Delta Adjusted at Close ("DAC") will also be available for electronic processing of cash-settled FLEX ETF options. Cash-settled FLEX ETF options are not fungible with non-FLEX options.

No cash-settled FLEX ETF option may have the same exercise style (American/European), same expiration, and same strike price as a non-FLEX option on the same ETF. This is the same restriction that exists today for physically settled FLEX ETF options.

If a standard option is subsequently listed with the same terms (i.e., same expiration date, exercise price, and exercise style) as a cash-settled FLEX ETF option with open interest, the FLEX option may be traded only as a closing position.

FLEX Option Symbols

Cash-settled FLEX ETF options are defined by the Lead Character in the symbol. Two new Lead Characters ('3' and '4') will be required to identify American and European-style cash-settled FLEX ETF options, respectively.

LIST OF CASH-SETTLED FLEX ETF PRODUCTS

Cboe may list up to 50 cash-settled FLEX ETF products. These products shall be FLEX Equity Options with an ETF underlying security having an average daily notional value of \$500 million or more and a national average daily volume of at least 4,680,000 shares, measured over the prior 6-month period.

- Twice per year the Exchange will determine the underlying ETFs satisfying the notional value and trading volume requirements of this rule using trading statistics for the previous six-month period.
- The Exchange will permit cash settlement as a contract term on no more than 50 underlying ETFs meeting the criteria of this rule.
- If more than 50 ETFs satisfy the notional value and trading volume requirements, the Exchange will select the top 50 ETFs with the highest average daily volume.
- If the Exchange determines, pursuant to the review conducted, that an underlying ETF ceases to satisfy the criteria, any new position entered into overlying such ETF will be required to have exercise settlement by physical delivery and any open cash-settled FLEX ETF Option positions may be traded only to close the position.

On the effective date, the following symbols will be eligible to have cash settlement as a flexible term.
