

# *Cboe Options Exchanges to Introduce Higher Bandwidth PITCH Feeds and Sunset 1G PITCH Feeds*

### **OVERVIEW**

Applicable Cboe Exchanges: BZX Options, C2 Options, EDGX Options

**Beginning May 20, 2024, through July 15, 2024**, Cboe BZX Options (BZX), C2 Options (C2), and EDGX Options (EDGX) Exchanges will make various PITCH depth of book market data enhancements to provide customers faster, more efficient real-time market data feeds.

## **TECHNICAL DETAILS**

#### Primary and Secondary 5G-shaped PITCH Feeds Available via 10G Connections

**Effective May 20, 2024**, the two 5G-shaped PITCH depth of book feeds (C and D feeds) will be published on all available 10G customer access switches. Customers can choose which feed(s) to take on their 10G connections. Weekend testing of this change will be available to customers on **Saturday, May 18, 2024**.

#### Sunset of 1G-shaped PITCH Feeds

**Effective June 15, 2024**, due to increasing bandwidth requirements, the 1G-shaped PITCH depth of book feeds will be sunset, and customers consuming these feeds will be required to migrate to the existing 5G-shaped PITCH depth of book feeds. The 1G-shaped TOP, Complex, and Auction feeds are not impacted and will remain unchanged.

The 1G-shaped depth of book feed sourced from the secondary data center (E feed) will also be upgraded from a 1G to a 5G-shaped Options depth of book feed. Due to bandwidth limitations, any customer with a 1G physical connection to the secondary data center (DR) will no longer be able to consume any PITCH depth of book Options feeds.

On the same effective date, the two remaining 5G-shaped depth of book feeds will be re-named from "C" (primary) and "D" (secondary) to "A" (primary) and "B" (secondary) to match the configuration and naming of the 5G-shaped depth of book feeds on the Cboe Options Exchange ("C1").

#### Introduction of 8G-shaped PITCH Feed

Effective July 15, 2024, customers currently consuming any PITCH depth of book feed can upgrade to the new C2, BZX, and EDGX Options 8G-shaped PITCH depth of book feeds (primary and secondary) by subscribing through the <u>Cboe Customer Web Portal</u>. Similar to the C1 8G-shaped PITCH feed, *the new 8G-shaped PITCH depth of book feeds will include a multicast IP address per matching unit*. Please refer to <u>Cboe US Equities/Options Multicast PITCH Specification</u> for more information. The new 8G-shaped PITCH feeds will be available in the primary data center only and will not be offered in DR environments.

The final state will result in two 5G-shaped (A and B) PITCH depth of book feeds and two 8G-shaped (C and D) PITCH depth of book feeds per market. This will match the configuration and naming of feeds used on C1.

#### **Feed Connectivity Requirements**

To utilize the 5G or 8G-shaped PITCH feeds, customers must have a minimum of 10 Gbps of connectivity to Cboe via cross connect or dedicated circuit. Members with sufficient connectivity may choose to take both the A/B (5G) and C/D (8G) feeds from Cboe and arbitrate the feeds to recover lost data.
