



## ***Schedule Update - Cboe BZX Options Announces Release and Weekend Testing Dates for Unitized Architecture, BOEv3 Protocol***

### **OVERVIEW (UPDATED)**

**Applicable Cboe Exchange:** BZX Options

Cboe BZX Options Exchange (BZX) is pleased to announce the release of version 3 of its Binary Order Entry (BOE) protocol on August 19, 2024, ~~July 29, 2024~~, *subject to regulatory review*. The BOEv3 protocol will offer fixed length messages, a single gateway per matching unit, and enhanced determinism.

### **TECHNICAL DETAILS**

#### **New BOEv3 Specification**

BZX has released version 1.0.3 of the BOEv3 specification, available in the Technical Specifications section of the [Cboe US Options public website](#). The specification includes a section highlighting notable differences between BOEv2 and BOEv3 to allow Members to better understand all pertinent v3 updates.

#### **Certification Requirement**

Members interested in using the BOEv3 protocol **will be required to formally certify with the Trade Desk** using the Certification Tool in the [US Customer Web Portal](#) prior to requesting any production BOEv3 ports. Certification ports will be made available per the schedule noted below.

#### **Updated BZX Order Entry Architecture**

In the BOEv3 architecture, a gateway server will be placed directly in front of each matching unit, and all traffic (including FIX and BOEv2 traffic) will pass through a BOEv3 gateway before reaching the destination matching unit. Members will be able to connect directly to unitized BOEv3 gateway processes for order, quote, and purge entry using unitized BOEv3 ports. Additionally, a BOEv3 convenience (BOEv3c) Order Entry port will be offered at the convenience layer to give firms continued access to all matching units from a single port. The convenience layer will also offer FIX and legacy BOEv2 connectivity with access to all symbols from a single port. While BOEv3c Order Entry ports will be available at the convenience layer, BOEv3 unitized (BOEv3u) Bulk Quoting ports will exist only at the unitized layer.

Inbound order, quote, modify, and cancel messages originating from any supported BZX order entry protocol will be deterministically ordered by the BZX system upon arrival at the applicable BOEv3 unitized gateway.

Members will be able to obtain BOEv3u Order Entry ports allowing for the submission of orders, BOEv3u Bulk Quoting ports allowing for the submission of both quotes and orders, and BOEv3u Purge ports allowing for the cancellation of orders and quotes across multiple ports for the same matching unit. BOEv3u Order

Entry, Quote and Purge ports can be ordered in sets, which will include a port for each matching unit, or individually per matching unit. Fees for BOEv3 ports will be announced at a later date.

Please be advised that BZX Options plans to decommission the BOEv2 protocol in favor of BOEv3. The sunset date for BOEv2 is targeted to be **February 23, 2025** ~~February 2, 2025~~. There are no plans to decommission the Options FIX order entry protocol.

## **TESTING OPPORTUNITIES AND WEEKEND TESTS (UPDATED)**

Members may begin requesting BOEv3c and BOEv3u ports in the certification environment on **June 3, 2024**, ~~May 6, 2024~~, after which time Members may also begin completing their BOEv3 protocol formal certifications using the Certification Tool in the [US Customer Web Portal](#). In addition, three weekend tests will be offered for Members who have completed the BOEv3 certification requirement and have requested Production ports.
