### Cboe Options 'Not Held' Orders to be Bookable from PAR

Effective this **Monday, January 31**, Cboe Options Exchange (C1) will allow 'Not Held' (*FIX Tag 20012*) orders to be individually booked from PAR using the 'Book' button. To avoid the possibility of orders being inadvertently booked, 'Not Held' orders will not be booked when the PAR 'Book All' button is pressed. Instead, only 'Held' orders will be booked when the 'Book All' button is pressed. See the **Tradedesk Update**.

#### **Cboe Global Markets Introduces New MatchingUnit Field on Purge Requests**

Effective **February 11**, on EDGX Options Exchange and EDGA Equities Exchange and **February 14**, on Cboe Options Exchange, C2 Options Exchange, BZX Options Exchange, BYX Equities Exchange, BZX Equities Exchange and EDGX Equities Exchange, the exchanges will enable firms to specify a matching unit for purge requests on FIX and BOE order entry protocols. # New Choe Options Off Floor Designated Primary Market Maker Approval – AMS Derivatives B.V.

Cboe Options Exchange has approved AMS Derivatives B.V. (AMS) as an Off-Floor Designated Primary Market Maker (DPM). AMS Derivatives B.V. is now eligible to participate in new product allocations and current product re-allocations on Cboe Options Exchange. Notifications indicating the physical trading location of each class, as determined by the Exchange, will be issued once new options classes are allocated to AMS Derivatives B.V. as an Off-Floor DPM.
